



Deb's Delights Contract Terms

1. Your initial \$50 deposit reserves your event date is non-refundable and non-transferable and will be applied to the purchase of your cake/desserts.
2. Payment in full is equivalent to a signed contract.
3. We must receive the balance by the final due date indicated, or contract is null and void, and no money will be refunded.
4. If your wedding/event is **cancelled within 60 days** of the event, at no fault of Deb's Delights, **a refund of 50% of monies paid (not including the Hold the Day deposit)** will be issued.
5. The date of your final payment is the deadline for any changes of size/quantity, style, flavor of cake/desserts. Any changes made to your order prior to the final deadline will be reflected in the final payment. Any changes requested after this date cannot be guaranteed and may be subject to additional charges.
6. Delivery fee in Chelan Valley is \$30-\$40. Outside the area, there will be a fee of .90 cents per mile, round trip, with a \$30 minimum.
7. We are not responsible for any damage to the cake/desserts after setup is complete. You are responsible for providing an appropriate and secure table and environment for the cake/desserts. Cakes are heavy and require a sturdy table, and optimal room temperature of 75 degrees or less. Depending on weather/temperature, cake/desserts may need to be setup inside or refrigerated, then moved to final destination closer to serving time.
8. If flowers are provided by an outside source, we will arrange up to 25 stems for free. You acknowledge that fresh flowers are not a food product, and may contain pesticides, insects, dirt, or other contaminants.
9. Deb's Delights is **not responsible** for setup of **cupcakes, mini desserts or other desserts** on the dessert buffet unless contracted to do so at \$50 per hour, minimum 1 hour.
10. If you, or your representative, elect to pick up and set up the cake, you assume all liability and responsibility for the condition of the cake once it leaves Deb's Delights possession.
11. We will photograph our cakes/desserts, and we reserve the right to use any photographs for display or promotion without compensation to you.
12. **Allergen note:** I practice high standards of kitchen safety to avoid cross-contact, but I cannot guarantee a 100% allergen-free environment. My equipment processes wheat, nuts, eggs, and dairy. I am **not** a certified allergen-free kitchen. You agree to notify your guests of this risk and hold us harmless for allergic reactions.

13. Every effort will be made to deliver on time; however, delivery of our cake/desserts may be delayed due to traffic, accidents, weather, acts of God and other causes beyond our control.
14. Please leave the cake topper and other cake accessories on the cake table. We will place your topper and accessories on the cake, per your request, after all assembly is complete. We will do our best to secure your accessories to the cake, but we are not responsible if it/they fall off or damages the cake.
15. All attempts will be carefully made to coordinate and/or match your colors, however, please be aware that food colors do not always perfectly match fabric, flowers, table coverings, napkins, etc. Depending on the mediums used, colors can be slightly altered by the ingredients (i.e. butter and cream cheese can cause slight variations).
16. If using our cake stacking system, the equipment must be returned to us in original condition and with all pieces, no later than **5 days** past the event date. If the equipment is not returned by the "Equipment return date", the credit card will be charged a replacement fee (minimum \$150). **Please do not wash any returnables.**
17. Please be aware that we are a busy bakery and usually have several wedding deliveries on the same day. If we have to wait for any reason after the agreed delivery time (such as locked buildings, or tables not set up, etc.) you will be billed at \$100 per hour. Also be aware that we will not be late for the next delivery because of your delay. If we must leave without setting up your cake, your cake will be delivered at the next earliest opportunity and might mean that your cake may not be set up in time for your event at no fault to us and without refund.
